### **PPG Meeting, Monday 7 August**

This month's meeting was a purely social affair and a small number of us enjoyed a convivial drink at the Greenwood. The consensus was that we should make this social meeting an annual summer fixture – and possibly a Christmas one too.

### **Meet the Patients – Volunteers Wanted**

We have "Meet the Patients" sessions schedule for Thursday 31 August PM, Tuesday 26 September AM, Tuesday 24 October AM, Friday 24 November AM and Wednesday 13 December PM.

I will be contacting those who have volunteered for 31 August in the next few days. However we still need volunteers for most of the other dates – please let me know if you can help.

### **Practice's Annual Patient Survey**

This year's survey was well received and the over 400 completed questionnaires produced useful results, on which I hope we and the Practice can build.

Patients continue to hold the Practice in high regard with 90% saying they are "Likely" or "Extremely Likely" to recommend the Practice. Nevertheless there continues to be significant dissatisfaction with the ability to get an appointment – something for which there is no good solution given current budget constraints. 95% of patients agree it is important we look after our own health but around 30% feel they need more information or knowledge to be able to do so – and this may well be an area where we, the PPG, can have a role. ### **A tough conversation about unnecessary GP appointments**

A London GP has recently called out the need for us to have much tougher conversations about unnecessary GP appointments. In one 2-hour session Dr Renee Hoenderkamp reports having seen 12 patients, none of whom needed a GP appointment, with most of them able to be either self-treated or treated by the local pharmacist. This is clearly not untypical and workloads such as this are unsustainable; we really do need to get everyone thinking much more about when to see their GP, when to visit the pharmacy, and when treat themselves – and that comes back to information, awareness and conversations about self-care. ### **Quarter of People Afraid of Doctor's Waiting Room**

A recent item in Practice Management magazine reports that around a quarter of us are afraid of visiting our GP, often as a result of a bad experience in childhood. A phobia of needles (for example) also plays a part. Interestingly around a third of us are terrified of visiting the dentist, while astonishingly one in six are anxious about going to the optician.

### **Refusing boys HPV vaccine saves the NHS cash but is bad science**

Human papillomavirus (HPV) vaccine has been available to teenage (or younger) girls in many countries for some years. However there are concerns that HPV can be orally as well as genitally transmitted, so excluding boys can result in a continuing spread of the virus and thus oral cancer. Nonetheless up to now boys have not been eligible for the vaccination as the costs were felt to

outweigh the benefits. But *New Scientist* reports that this decision is poorly conceived and the vaccine should be offered to all adolescents. ### **Could the NHS save money by getting it right first time?**

Orthopaedic surgeon Prof. Tim Briggs wants the NHS to do better by getting everything right first time. His mission is to ensure hospital practices are standardised to reduce variation in outcomes and adverse outcomes and hence save the money otherwise needed to correct them. This seems to be rather a novel concept in the NHS, but it really shouldn't be as it is the way most industries have worked for decades – this, with a rigorous investigation of all problems, is why the airline industry has so few accidents. ### **NHS plans to scrap homeopathy treatments**

Elsewhere in the NHS there's a drive to stop GPs (especially) prescribing treatments which are seen as of low value (eg. homeopathy and some drugs) or which the patient should be able to buy much more cheaply over the counter (eg. paracetamol).
