#### **Coronavirus**

Ealing CCG's latest PPG Newsletter (linked below) which was published before the Tier 2 restrictions cam into force in London says:

"The Government's expectation is the measures described above [basically Tier 1] will need to remain in place until March."

That's interesting, because it's the first time I've actually heard anyone acknowledge this.

#### **Cancer Detection in NW London**

Over two million patients across NW London are to benefit from a new diagnostic tool that helpsto detect cancer in its earliest and most curable stages. The tool, which has shown a 30 times improvement in the detection of cancer, has been rolled out to more than 400 GP practices across NW London. ### **Ealing CCG AGM**

I represented the PPG at Ealing CCG's AGM on 14 October. As expected this covered the CCG's activity in 2019-20, and alsomuch of the work being done this year on the Covid-19 pandemic. Very, very brief highlights include:

- CCG's deficit in 2019-20 was £51m; and they expect to be deficit by £100M in 2020-21
- · Lots of work to support care homes, community services and GP new ways of working through Covid-19
- · There is an assumption that the single NWL CCG will go ahead on 1 April
- I raised questions about delays in assessments for autistic children (yes they know but it isn't getting fixed quickly enough),
   and about the lack of PPG engagement from the Primary Care Networks (this is being followed up).

#### Flu Vaccine Supplies

This year, as in most years, there are concerns over the supply of flu vaccine to GPs. I've not heard anything about this in the last couple of weeks, so hopefully it is a fairly isolated problem. ## NHS "One Stop Shops"

The NHS is planning to introduce "one stop shops" in the community to provide life saving health checks. The intention is to create these community diagnostic hubs across the country, away from hospitals, so patients can receive life-saving checks closer to home; the centres could be set up in free space on the high street or in retail parks. As the plan talks about lots of CT scanning, and the need for some 4000 new radiographers (let alone any other staff) this is going to need a vast amount of morey, which I remain to be convinced is available – but we shall see; it'll be good if it can be made to happen.
