Coronavirus

There's not really a lot to say now, as no-one is saying anything. The government have stopped testing and reporting, and vaccination is no longer available. The Zoe Covid study (https://health-study.joinzoe.com/data; the only useful data we have) are still reporting around 650,000 current infections, with around 40,000 new infections daily. That's the lowest rate for at least two years. Hopefully incidence will fall further over the summer, although we should probably expect a peak after the holidays and when schools go back.

Meanwhile Prof. Christina Pagel (Director of Clinical Operational Research Unit, University College, London) has written an article in *The Conversation* making a good case for the vaccination of all children. Abuse of Doctors by Patients

There was a recent article in the *Guardian* reporting on a survey conducted by the Medical Protection Society. The survey questioned almost 1000 doctors and found 56% of them had either directly experienced or witnessed abuse by patients (or their relatives). This included physical abuse and verbal, including racial, abuse. The public are urged not to take out their frustrations on doctors or their colleagues as they share the same frustrations and are acutely aware that waiting times are too long. It must also be stressed that violence, abuse or misconduct towards NHS staff is unacceptable at any time,
