Apologies for the extra email, but this is important and I didn't want to leave it for my Monthly Update.

I have received the email below from NW London NHS. It seems to confirm what I have already heard: that across the whole NW London area same-day GP appointments will be provided only by local hubs and not by GP practices – and that this is mandatory. Moreover it appears that a large number of the same-day appointments will be done by Physician Associates (ie. not qualified doctors) with only 2 years training, little GP oversight, and who are not legally allowed to prescribe.

So far I do not have much of this directly from the NW London ICB – I have only their email below and the letter it references which are somewhat vague – but one can read between the lines. However there are reports in respected medical media which highlight what I have said above, apparently based on NWL ICB board papers etc.

It is clear some of the detail is still being decided, but **if** (note **if**) these reports are accurate there are many concerns, not least the safety and the continuity of care – plus much more! But of course this may all turn out to be a storm in a sick bowl – we've been here before.
