#### Coronavirus

Sadly Covid infection rates are on the rise again and we seem to be in a summer wave. Should we be surprised? No, with the level of waning immunity an the relatively poor take up of the (restricted) Spring booster this should not be a surprise. How big is the wave? We don't know, because there's no testing and reporting of results, except in hospitals – and it is the number of positive tests in hospitals which tell us there's a wave happening. The wave seems to be down to the FLiRT variants KP.1, KP.2, KP.3 which are descendants of the earlier JN.1; and it appears to be hitting the elderly (especially the over 85s) hardest. But, again, we don't know for certain. Basically we're flying blind. So if you are at all vulnerable, in my opinion you would be wise to continue wearing a mask. ### **PPG Awareness Survey**

#### **ICB Deficits**

Many Integrated Care Boards (ICB) – essentially local NHS governors – are struggling to stay within budget. One reason is the ever escalating cost of providing healthcare and the fact that central funding is not keeping pace. They are also being asked to make, often huge, efficiency savings. A recent survey for *The Lowdown* (evidence based journalism on the NHS) found that very few actually expect to stay within budget.

Our NW London ICB is one of those affected. Apparently they have a plan to reduce the number of available beds as part of a plan to limit their 2024-25 deficit to a mere £80million, although this is on the assumption they can also reduce the number of jobs by 3000 Full-Time Equivalents (FTEs). Which jobs? We don't know. But we should probably expect services to get even worse. ### More GP Appointments in May than Before Pandemic

NHS data shows that GP teams delivered around 30.5 million appointments in May 2024, compared with an estimated 25.3 million in May 2019. That's an increase of over 20%.

Looking at the (publicly available) Barnabas data, in January-March 2024 the Practice provided 15854 appointments, up 15% on the same period in 2023.

## Whooping Cough

UKHSA seem to be playing down the current increase in Whooping Cough (Pertussis) rates. However statistician Paul Mainwood suggests that this is wrong; it isn't supported by the data; and the situation is far worse than UKHSA are implying. #### **Cervical Screening**

The NHS is urging more women to take up their cervical screening invitations. As of December 2023, just under 2 in every 3 of the 11 million eligible women aged 25-49 took up their cervical screening invitation. That means over 3.5 million are missing out on this screening. NHS article at

#### 2024-25 Flu Vaccinations

Details are becoming available of this Autumn's flu vaccination programme. From September flu vaccine will be available to children (although it looks as if many 4-year-olds are excluded) and pregnant women. From October eligibility is extended to the over 65s, those in high risk groups, those in care homes and front-line social care and healthcare staff. However we don't yet have the full details of timing.
