# **Infectious Disease Update**

#### Covid

The good news is that the incidence of Covid is still at low levels. Although infection levels have been creeping up for some weeks (and the experts were predicting a summer wave) the very latest data today suggests that rates have fallen in the last couple of weeks. It'll be interesting to see if that is real, or just random noise.

The not so good news is that the government have announced the groups eligible for this Autumn's Covid boosters, and it's the same as it was this Spring:

- adults aged 75 years and over
- · residents in care homes for older adults
- individuals who are immunosuppressed aged 6 months and over

So hard luck again to those of us still under 75 but with a number of comorbidities.

# Weight-Loss Jabs

Thousands of patients in England are now able to access Mounjaro (tirzepatide) weight-loss jabs via their GP. However the initial rollout is to 220,000 patients across England. NW London NHS have said that in the first phase around 900 people in North West London are expected to qualify. Eligibility will require individuals to:

- be over 18
- have a BMI of 40 or more (or over 37.5 for some ethnic groups)
- have at least four obesity-related conditions (eg. type 2 diabetes, high blood pressure, cardiovascular disease).

In addition Mounjaro will only be offered as part of a comprehensive care plan that includes:

- lifestyle changes
- behavioural support
- increased physical activity.

### **New Look Uniforms for NHS Staff**

The new uniforms are for nurses and those with specialist roles (eg. pharmacists). However doctors – who are not required to wear uniforms at all times in hospital – are not included in the new colourways.

A reminder that from 1 August, gay, bisexual and other men who have sex with men, will be eligible for routine Mpox and 4CMenB for gonorrhoea vaccination programmes. Those eligible will be identified opportunistically, including by GPs, and the vaccination will be delivered through sexual health services.

# **Pioneering Cancer Treatment**

NHS England will be the first health system worldwide to roll out the pioneering treatment Blenrep for blood cancer patients. This targeted therapy has given promising results in halting the progression of myeloma for nearly three times as long as current treatments.

### **British Woman Dies from Rabies**

A woman in Yorkshire has died from rabies after she was scratched by a puppy in Morocco. UKHSA said there is no risk to the wider public as there is no documented evidence of rabies passing between people. However UKHSA remind travellers to be very careful around animals when in rabies affected countries – especially in Africa and Asia.

# **National Maternity Service Investigation**

The Health Secretary has announced a national investigation into maternity care in England. The "rapid" inquiry will urgently look at the worst-performing maternity and neonatal services in the country.

### **GP Patient Charter**

NHS England has published the "patient charter" setting out the standard of care they are contracted to provide. Practices will be required to publish (including on their website) a "publicly accessible document", setting out what patients can expect from their GP, and what to do if patient expectations aren't met, as well as what is expected of patients. This is expected to become mandatory before the end of the current financial year.

# **New GP IT System**

NHS England have approved a new IT system for GPs. This is the first new system in the last 25 years. The new system from Medicus Health is already live in four early-adopting sites, serving over 42,000 patients. Medicus Health is the first new supplier to be fully assured through NHS England's Tech Innovation Framework, which ensures new products are fully compliant on information governance, clinical safety and data protection, while integrating with NHS infrastructure such as the Electronic Prescription Service, NHS e-Referral Service and NHS App.

### **GP Funding Formula Review**

Not before time, it has been announced that the Carr-Hill formula used for calculating GP practice funding will be reviewed as a part of the NHS 10-year plan.

### **Hundreds of NHS Agencies to be Scrapped**

Over 200 NHS quangos and agencies will be scrapped as part of the upcoming NHS 10-year plan. Organisations scrapped will include Healthwatch England, Health Services Safety Investigations Body, National Guardian's Office and Commissioning Support Units. The Health Secretary has said the current system is too complex and needs fewer admin overheads, with over 150 bodies responsible for regulating or assessing healthcare services in England, which risked overwhelming staff with uncoordinated guidance.
